Allowed for groups of 50, total venue cap of 500, density quotient of 1 per 4m2

#### Organising a private religious ceremony

Please obtain permission from the Chief Monk of Vihara and inform Secretary of BVV Inc. via <a href="mailto:committee@vihara.org.au">committee@vihara.org.au</a> if you are organising a private religious ceremony at the temple.

Visitors need to observe the following procedures:

- Stay home if you have any symptoms of illness or have been in recent contact with a suspected case of COVID-19
- Sign in with the attendance sheet upon arrival for contact tracing
- Make use of the hand sanitiser stations and wash hands
- Do not exceed posted occupancy limits given
- Avoid touching your face, eyes, nose or mouth; cover your mouth when sneezing or coughing
- Avoid shaking hands, hugging or physical touching
- Visitors are encouraged to maintain 1.5 metre social distancing when you are in the Temple Premises.
